Description:

Oncologic patients often present into community-based emergency rooms across the country and require specialized treatment, care and attention. Because there are so few cancer-specific emergency rooms, these patients are often being treated by healthcare providers that might not have the appropriate knowledge, skill or experience to make accurate diagnoses. This two-day, live virtual course will include interprofessional panels, as well as lectures from experts in the field to update and improve the treatment and care for the oncologic patient.

1 Identify 2 of the most up to date approaches for managing oncologic emergencies in an emergency department setting
2 80% of the participants will articulate increased knowledge of the importance of effective communication and teamwork while managing oncologic emergencies
